

# Deporte Mutual Members Firearms Protection Statement of Protection

# Name of Beneficiary:

Members of the Sporting Shooters Association of Australia (Queensland) Inc. who have opted to take out this cover.

# Period of Protection:

Means the period that the Member is covered. The protection period is the same period as your current SSAA Queensland Membership period, unless you have purchased the cover after the Membership effective date, in which case, the protection period is effective the date that you purchased the cover and expires on the same date as your Membership expires. For life and 5 year Members, the policy period is no greater than 12 months and expires on the anniversary of your current SSAA Queensland Membership period.

#### **Interest Protected:**

Privately owned firearms plus fixed accessories specifically limited to the following items: Scopes / sights, straps, gun bags / cases, tripods and bipods.

#### **Covered Perils:**

Theft, Accidental Damage and Accidental Loss of the equipment (including whilst in use).

## **Basis of Settlement:**

We will pay the Replacement value for any equipment up to 5 years old. For any equipment over 5 years the settlement will be Market Value only.

#### **Endorsements:**

Cover will not be claimable;

- For theft where the equipment was not stored in an approved gun safe as required by State or Territory authority, other than when the equipment is in use or away from the Member's premises
- Where the Member or any person or entity to whom the equipment has been entrusted to fails to comply with any law relating to either storage, use or handling of the equipment
- Notwithstanding anything in the Policy Wording or schedule to the contrary it is agreed and declared that this policy does not cover any loss or damage to unaccompanied customers goods, whether in the course of or awaiting transit, during loading or unloading, or being held in storage
- Where the damage has resulted from maintenance of the gun.
- For scratching and chipping of stocks.

## Geographical Limits:

Within Australia. Includes overseas cover for 28 days any one trip.

# **Sums Protected:**

Limit of Indemnity up to \$25,000 any one loss and in the aggregate.

### **Excess:**

\$100
